ORGANISATION BACKGROUND

I. GENESIS

Social Education Economical Development Society (SEEDS) is a non-profit organization promoted by Mr. S.D. Pandian, a Sarvodaya Worker. He has been associating himself with Sarvodaya Movement of Achyarya Vinoba Bhave for nearly more than two decades. It is to be noted that his father and grandfather also played active roles in the Sarvodaya Movement. Mr.S.D.Pandian with his rich experience in promoting ideals of the Gandhi voluntarily initiated rural development activities with the help of like-minded people in the surroundings of Aruppukottai, Tiruchuli and Kariyapatti Blocks. To strengthen the services better, a society was registered namely, "Social Education Economical Development Society" (SEEDS) in the year 1995 under the Tamil Nadu Societies Registration Act 27 of 1975.

The mandate of the organization is to enable marginalized and disadvantaged rural women to achieve their socio-economic development through a process of organization and participation. In pursuant to this end, **SEEDS** has been reaching out to more than 60,000 families in hundreds of villages in Virudhunagar, Ramanathapuram and Thoothukudi, Madurai, Kanyakumari, Karur, Thiruppur Districts of Tamil Nadu. SEEDS implements many number of socio-economic programmes, with the support of agencies of the state and central Governments and Foreign Funding Agencies including commercial banks.



The SEEDS, a non-governmental organization promoted many FPCL for the welfare of the farmers, SHG / PLF members who expressed their demand on the intervention in agriculture input needs, technical assistance and affordable financial services. FPOs promoted by SEEDS POPI / RI under the facilitation of NABARD / SFAC in Virudhunagar district with the major focus crop of Millet & Pulses. The reason for the emergence of FPCL is: failure of monsoon rains, migration of labours from rural to urban regions for want of employment opportunity during agricultural season, Need to pay excess wages for the available labours, Need to spend more money is required to procure input materials, delayed take off of Agriculture activities—due to non-availability of seeds, fertilizer, pesticides during the appropriate time, diminishing crop area due to inferior quality of seeds with lower germination rate, non-availability of agriculture implements during harvesting, interference of Local merchants on the procurement price of agriculture produce & non-availability of storage facility during surplus production of agriculture.

The Mobilization part of the FPO Initially started with the existing FIGs, JLGs and lead farmers who came forward to form the producer company and the company gets registered. Now all the group companies have 16537 shareholders of which the Male farmers constitutes 6447 numbers (39%) & Female 10087 (61%) and the with the coverage of around 78% - small and marginalized farmers working in seven districts of Virudhunagar districts of South Tamil Nadu.

FPOs are having the paid up share capital is Rs 175 lakhs. Obtained Rs 10 lakhs as equity grant from SFAC, New Delhi of around 60 lakhs for 6 FPOs and the funds were allotted to the share holder farmers as equal shares. The main activities undertaken by the FPCs are Input Supply, Capacity building training, Technical assistance, Procurement, Forward & Backward marketing linkages. All the FPCLs have obtained all the required certification from the Government like License for SEED, Fertilizer, Pesticide, fssai, PAN, TAN & GST. The Business activities undertaken by the FPCs are Procurement of commodities, Value Addition, establishing Agriculture Business Centres (ABC) and On-lending for farm production & livestock rearing. The Business turnover of all the FPCL during 2017-18 is Rs 22 Crores and the net profit earned is Rs 25 Lakhs.

FPCL is planning for a turnover of Rs 40 Crores in this financial year 2018-19. All the companies earned profits from Collectivization & marketing, Procurement and Value addition of commodities, Sale of commodities through ABC centres & On-lending credit to farmers.

The credit needs of the farmers are met through Samunnati, Ananya, Nabkisan of around Rs 22 crores. The FPCL is governed by 10 active Board of Directors. The financial assistance for the promotion of these FPOs are supported by NABARD & SFAC around Rs 9.06 Lakhs & 40 Lakhs respectively for 3 years and it is professionally utilized for the support and strengthening by POPI / RI. SEEDS POPI arranged and conducted various training programs to Board of Directors, CEO and staffs on FPO promotion & strengthening, Value chain management and Governance and monitoring & thus monitoring the entire progress periodically.

Innovative initiatives have been implemented in matured FPCLs like Digitization of Farmer Data, Geo tagging, geo audit, Farm Production and prediction of Yield, Inventory

Control System & Procedures, Sustaining the second generation youth in Agriculture & SEEDS Resource Institution initiated a Project with Bharat Rural Livelihoods Foundation (BRLF), New Delhi - 2018-21 on "Improving market readiness of Smallholder farmers practicing Non Pesticide Management of Agriculture" & to develop a Consortium of 22 network partners in 8 states of India-working with 1 lakh farmers to practice NPM.

The marketing strategy of the FPCL is being done by two ways. One to sell the value added commodities to their own shareholders at least for Rs 1000 per farmer household & thus can expect a turnover of Rs 10 Lakhs per month through Agri Business Centres (ABC) in FPO office & Rural ABCs. & another by linking the commodities to the corporate buyers like M/s. Safe Harvest, Nilons, Phalada etc...

ADOPTED SOLUTION & OUTCOMES:

- 23. Establishment of *Agri. Business Centre* at the FPCL office to cater the monthly groceries need of share holders at comparatively lesser coat than the market.
- 24. Facilitating all the farmers with credit, inputs, improved crop production technology, digitization of agriculture, weather advisory, yield prediction, linking with the main stream market, and Promotion of Organic Agriculture.
- 25. RI facilitated direct procurement from farmers & marketing the commodities. This year it is entering into the consolidated marketing of produce to corporate buyers and value addition of the Agricultural Produce through processing mills and seeking the linkage for the marketing opportunity from top notch corporate. Next year FPO is planning for the setting up of processing hubs through its own infrastructure -mills & machineries and also aims at Agriculture digitization of farm data base, advisory for weather, disease incidence, crop productivity, growth monitoring & yield prediction and Organic farming by the way of transforming atleast 15 % of the farmers to natural production methods and to enable them a premium price for their Produce..
- 26. Increased income verified by means of decreasing expenditure on their inputs & additional income for their agriculture produces over 5-10%.
- 27. Facilitating all the farmers with credit, inputs, improved crop production technology, digitization of agriculture, weather advisory, yield prediction, linking with the main stream market, and Promotion of Organic Agriculture. During the agricultural off season, it aims to facilitate the farmers with goat, cattle rearing and thereby increase the income of the farmers and attaining the sustainability and make good interventions in each and every step of the value chain of the Agricultural Commodities of the shareholders.












SEEDS ORGANIZATION STRUCTURE

SEEDS is acting as Rural Distributor to the promote distribution of Tea in Rural area under the corporate Social Responsibility activities of TATA Global Beverage Limited. The rural distribution activities are carried out through SEEDS in 13 districts SEEDS identify potential organization / rural Youth and involving them successfully organize the distribution activities. Under this programme 71 rural entrepreneurs generate an average income of Rs.6000/- average per month. It is a new opportunity to rural youth and middle aged men and women who are gaining knowledge and practice in rural trade and business.

Objectives:

- 1. To Carry on business of dealership and to act as producer, distributor, dispenser or in the form of franchisee in growing, processing, marketing or deal in all kinds of agriculture, and floriculture products, woods commercial woods, crops, seasonal crops, fruits, plant, tea, coffee, medicinal herbs, flowers, seeds, sapling fertizers and their product and social and commercial forestry and agricultural, and floriculture activities including certified hybrid foundation and any other kind of seeds, plants, drip irrigation system and the trees of all varieties.

3. To act as a facilitator, catalyst, mediator or promoter in obtaining or arranging micro credit and financial assistance to self Help Groups and body of individuals from banks, public financial institutions, Nidhis, Chit Funds and other authorized sources.


